#### **Unlawful Financial Conduct in the Charter School Setting**

Schools and school leaders are increasingly facing the threat of state audits, FCMAT audits, Attorney General investigations, Office of Inspector General investigations, and criminal prosecutions for allegedly unlawful uses of charter school funds for activities that many charter schools consider routine business. These allegations have led to closure of high-performing charter schools even where there have been no arrests, indictments, or convictions. This workshop will explore applicable statutes, cases, and audit reports to demonstrate the changing landscape on these issues.

## **Protecting Student Rights While Ensuring Campus Safety**

Charter schools are regularly confronted with campus safety issues, both due to student discipline and when law enforcement or other government actors come to the school for access to students. This presentation provides an overview of recent changes to the law related to immigration enforcement issues (AB 699), changes to laws impacting the rights of minors, and changes to student discipline requirement (AB 1360). Attendees will leave with a better understanding of how to balance cooperation with law enforcement, providing a safe campus for your school community and protecting student's rights.

### Handling Employee Leaves and Accommodations

This session will provide guidance to assist your school in ensuring it can successfully navigate the complex legal requirements set forth by the Family and Medical Leave Act, California Family Rights Act, Pregnancy Disability Leave laws, the Americans with Disabilities Act, and the Fair Employment and Housing Act. Discussion will center around eligibility for and purpose of leaves and reasonable accommodations, leave interactions, obligation to continue health benefits, reinstatement rights, and the consequences of violating leave/accommodation laws.
